RIFLE LOAN AGREEMENT

Rifles or the property of the Iowa State Rifle and Pistol Association ("ISR&PA"), and is intended for use in Civilian Marksmanship Program ("CMP") and National Rifle Association ("NRA") events, by both adult and juniors, to develop proficiency in the use of rifled arms.

Members will be responsible for the safekeeping of the equipment in his/her custody and will return in the same condition in which it was issued, last normal wear and tear. Storage and use of this rifle, while in the member's possession, must be in compliance with all applicable local, state and federal law.

The member requesting a rifle will prove that they may possess a firearm by providing a copy of a CCW permit or a permit to Purchase documentation provided by their county sheriff.

The member will pay a fee of \$40.00 to the ISR&PA Maintenance Fund, and post a deposit of \$80 (for a total of \$120). The \$80 deposit will be refunded upon return of the equipment, except as noted below.

The equipment will be return to ISR&PA Firearms Custodian **no later than December 1 of the year in which it was issued,** unless special arrangements are made with the Firearms Custodian IN ADVANCE. Failure to return the equipment per this paragraph will result in forfeiture of deposit, and the rifle will be considered stolen.

If the member fails to provide proof that he or she fired the rifle in and NRA approved or registered match, or a CMP "leg" match, deposit is forfeit.

If the rifle is damaged, other than through normal wear and tear, the member will pay full repair or full replacement value (per the Firearms Custodian). Deposit will be applied to repair/replacement.

If the rifle is lost or stolen, the deposit is forfeit and the member agrees to pay full replacement cost of the rifle and is indicated by the Firearms Custodian of the ISR&PA. Deposit will NOT be credited to replacement cost in this situation. Failure to pay this replacement cost will result in Small Claims Court action by the Firearms Custodian of the ISR&PA.
