LOCATION: Drive 2 mi south of Montezuma on Hwy 63 to 510th Av (large grey silo). Turn east (left) onto 510th Av (gravel) for 3/4 mi. Range is on the left. Address: 1293 510th Av, Montezuma, Ia.

RIFLE: Any centerfire rifle capable of holding 5 Rds.

START TIME: 1:00 pm

COURSE OF FIRE: All firing is at 100 Yd. All sighting shots (2) will be fired before each match. Only the Range Officer or Supervisor may use the scoring plug. Competitors will score.

National Match Course of Fire

Match #1 – 2 sighting shots and 10 rounds for record, standing, slow fire, SR-1 target. 20 minutes.

Match #2 - 2 sighting shots and 10 rds for record, sitting or kneeling, rapid fire, SR-1 target. 60 seconds for 10 Rds.

Match #3 - 2 sighting shots and 10 rds for record, prone, rapid fire, SR-21 target. 70 seconds for 10 Rds.

Match #4 - 2 sighting shots and 20 rounds for record, prone, slow fire, MR-31 target. 20 minutes.

ENTRIES & FEES: Adults - \$10.00 Jrs - \$5.00 unless scores are not sent in, then \$0.. Entries will be limited to 14 competitors.

MATCH RULES: NRA Rules will govern.

CLASSIFICATION: NRA rules, 19.6 in effect. Jr's will shoot in JR, IJ, SJ classes.

SAFTEY: Eye and hearing protection recommended . Open Bolt Indicator required/available at check-in.
